## Words of welcome

### Paavo Arhinmäki, Minister of Culture and Sport



It is my great pleasure to welcome ENCATC 2011 Annual Conference and all its participants to Helsinki.

It goes almost without saying that the title of the Conference - "Culture Forecast" - is indeed topical. We are all preoccupied with trying to make sense of all the changes that are currently transforming our societies, cultures, and economies. I don't think that there are any Ministers or Ministries of Culture anywhere who wouldn't be trying to strike an appropriate balance between safeguarding our cultural institutions and finding new models for cultural governance.

Obviously, this exercise takes place in a context of drastically diminishing public spending and important changes in cultural needs and consumption by our citizens. Both phenomena pose their distinct challenges, but also opportunities.

However, I want to emphasise that not everything is changing. As far as Finland is concerned, I fully subscribe to basic cultural policy objectives as enshrined e.g. by the Council of Europe; i.e. promoting cultural identity, diversity, participation and creativity. They remain valid and form a cornerstone also for today's cultural policy agendas. The question is how to ensure the attainment of these objectives in today's circumstances.

Here, we don't start from scratch. At the European level, the European Agenda for culture by the European Commission, reflection on new models for cultural governance by the Council of Europe, and our domestic reflection in the form of Cultural Policy Strategy 2020 and the Government Report to the Parliament on the Future of Culture provide not only useful reflection but also put forward a number of concrete courses for action.

Since I cannot do justice to or elaborate the wealth of information and intelligence contained in these, and other, documents, let me concentrate briefly on two aspects that may be of relevance to your conference: cultural institutions and the interplay between culture and other policy objectives.

In several countries, cultural institutions - from national operas to municipal libraries and cultural centres

- have a prevalent role both as recipients of public funding and as providers of cultural services to citizens. In Finland, they form the backbone of cultural infrastructure and are significant employers.

However, both the imminent cuts in public spending and changes in patterns of cultural consumption, especially by younger generations, pose significant challenges to cultural institutions. I am convinced that different cultural institutions will continue to play a crucial role as cultural service providers and local cultural hubs by opening up even more to their surrounding cultural ecosystems and by becoming centres of excellence that dynamically enrich their communities and enable cultural creativity and participation to flourish. Ensuring that managers and staff of cultural institutions posses the skill-set needed is, of course, a key in this respect and ENCATC has an important role to play in this connection.

The other, rather obvious, remark that I want to make, is that culture is not a detached part of our societies. Quite to the contrary, it is the foundation of all societies. I adhere to the analysis by the UK think-thank Demos, who pointed out that the old understanding of culture as an indulgence that societies may tolerate, is, well, an old and redundant view. Instead, it is clear that culture does, in addition to its inherent role and as a clue binding societies, bring significant added value to a number of other policy objectives. These include, among others, economic, social, development, and external relations policies.

To put it succinctly, there are several policies and policy objectives that affect culture and cultural policy and vice-versa. Managing and harnessing this interplay between different policies is vital in ensuring the policy space needed for effective cultural policies. The UNESCO Convention on the Protection and Promotion of Cultural Expressions is a prime example in this respect. It is the first multilateral treaty on cultural policy and, indeed, a Magna Charta for international cultural policy.

I would encourage cultural managers and workers to develop, and effectively communicate, arguments and cases on different positive impacts of culture.

After all, culture is not an indulgence belonging or affecting only some of us, but the very essence of being a human. Culture belongs to everyone!

I wish you a stimulating and productive conference and look forward to receiving the conference report.



## Keynote speakers

#### Dr. Saara L. Taalas - Linnaeus University, Sweden

Professor Dr. Saara L. Taalas is IKEA Professor of Business Studies in Linnaeus university, Sweden and Professor of Media Business and Head of Media Futures Network in Turku University, Finland. She holds visiting professorships in management in Universities of Jyväskylä and Oulu, and associate professorship in organization theory in Lund University. Her research interests focus on the boundary conditions of organising and management in cultural and media economy and dynamics of soft innovation. She gained the degree of Doctor of Philosophy in Industrial and Business Studies, Warwick Business School, Warwick University UK (2001). Her work has been published in journals such as Entrepreneurship and Regional Development, and Management and Organizational History. 

Seminar: Culture Does Good!! Room: 423

Jukka Saukkolin, R&D Manager, Turku European Capital of Culture 2011, Finland Dr Jenny Elliott, Arts Care CEO, N.I. and practicing dance professional, United Kingdom

Within ENCATC our strengths lie in two areas: in education/training and in administration. We have important competencies to offer in order to enrich cooperation between the arts and the social and health services. In this meeting we will focus on the role of art, artists and cultural managers in this context and discuss which opportunities and challenges we consider relevant for the future. How does education/training monitor these changes?

The first keynote speech of the meeting will offer a presentation on "Turku 2011: Culture does good" by R&D Manager Jukka Saukkolin. Well-being is a main objective of the European Capital of Culture year. Culture does good and culture and artistic work are of value themselves. This twofold approach to culture is at the heart of the year. Since 2008, the theme is emphasized from different perspectives such as communality and active participation. Nearly half of the productions of the year demonstrate partnership between culture and well-being. The other keynote speech, Dance Mirrors, delivered by Dr Jenny Elliott from Arts Care, N. I. articulates how to use dance practices and embodied knowledge to inform and generate a contemporary arts-based management methodology. The presentation will also assess the meaning and evaluate the impact of a professional contemporary dance residency practice within a specific trauma recovery healthcare environment.

This seminar is for everybody who shares the opinion that art, art based practices and services are important for rehabilitation and for community and social purposes. Art and arts based practices within health settings have been widely discussed over the past few years as there is an obvious, growing demand and financial pressure for finding and developing new and more effective working methods. Arts and health are also viewed as a growing sector in the meaning-intensive production and creative economy. For an artistic community this context can offer job opportunities.

There is a demand for bridge builders!

To achieve the objectives of the EU 2020 strategy, the European Union is asking for a better relationship between the culture sector, educational institutions and industries through reinforced cooperative schemes. This ENCATC seminar is a challenging event aimed at creating synergies between two sectors with different aims: the cultural industries and cultural heritage.

The seminar will take the shape of a workshop addressing several key questions. The cultural field is often described as being an ecological system of different processes rather than a mechanic, linear one. There is a great mix of processes and it is difficult to obtain a clear overview of the system, which involves cultural and social entrepreneurship, civil society, voluntary actions, high artistic quality, and aesthetic values. The labour market is highly volatile consisting of short- or longterm projects or contracts. Working voluntarily is as common as paid job opportunities. A highly valued competency is, today, to be able to navigate and understand the ecology of the cultural field which can reach from voluntary work to great international success-stories. What does that mean for us as educators and or trainers preparing future cultural managers to work in the field of cultural heritage and cultural and creative industries?

The crucial point in the seminar is our role as educators. We will look at clips from a film showing an example from a success-story in 1930s Sweden, bringing it up-to-date to see similarities and differences. We will ask questions such as what system needs to be in place in order for an artist or cultural manager to be able to succeed. What should be taught at our training institutions?

The workshop is a participative one where participants share experiences and knowledge.

#### Seminar: Cultural sustainability of a city in precarious times Room: N1

This topic was discussed in Barcelona (2009) during the ENCATC 17th Annual Conference, where a special session was devoted to urban sustainability. Cities have been seen as special cultural ecosystems which, to put it in the words of Jordi Marti, Barcelona Culture Councilor, plant the seeds of sustainable development where culture will play a central role. This theme was re-energized in the framework of the 18th ENCATC Annual Conference in Brussels (2010) at the seminar devoted to Cultural Innovations and Creativity as an Engine for Sustainable Urban Development.

Unquestionably, in times of tight budgetary constraints, this topic gains new importance. And although it has been implicitly touched upon in such visionary documents as Europe 2020 strategy, where the priorities for smart, sustainable and inclusive growth have been set up, including the idea of smart cities, it still deserves to be further elaborated and illuminated. On the other hand, although over the last two decades culture is increasingly recognized in the theoretical analyses and various NGOs platforms as the fourth pillar of sustainable development (along with economic vitality, social equity and ecological balance) it is still treated more as a decorative element than an aspect of the overall planning in political strategies and programs. With the belief that understanding the multiple meanings of sustainability and the central role of culture in this framework is critical to advance this new priority for effective urban governance, we invited Dr. Katriina Soini, Chair of the COST action IS1007 Investigating Cultural Sustainability (http://www.cost.esf.org/domains actions/isch/Actions/IS1007) to present and debate with us various discourses on cultural sustainability and to present the newly initiated action of COST program of ESF. The main discussion topics are: Understanding better cultural sustainability of cities; Creativity and innovation as engines for cultural sustainability of European cities; Mapping successful examples of cultural innovative events and accounting their effects upon urban sustainable development; New innovative networks between universities, NGO-sector and urban administrations; Practice-led education programs for development of new competences for sustainable urban governance.

Monitors of Culture is a unique platform of academics, researchers and cultural observatories. Its aim is twofold: set up a framework to discuss and exchange best practices as well as to improve the design and the evaluation of culture policies in Europe. It is led by Cristina Ortega from the Institute of Leisure Studies of the University of Deusto in collaboration with institutions such as the Budapest Observatory (HU), ATER Fondazione (IT), and the Observatoire des Politiques Culturelles (BE). Monitors of Culture is one of the initiatives emerged from the Working Group of Cultural Observatories and Information and Knowledge set up in 2007 by ENCATC.

The main outcome of the PG in 2010 consists of a final publication: « Monitors of Culture » both in English and Spanish. This book is organised in different parts, according to the following structure: the "SaCO", the State of Art of Cultural Observation; a section with key articles focusing on different topics; and a set of Recommendations on the conditions needed for the setup of a Common Cultural Observation Methodology (CECOM). This seminar in Helsinki will be the first occasion to present this publication to a widely International audience.

The presentation will be followed by an interesting talk about the gathering of cultural data and cultural statistics in Finland as well as about the creativity of Helsinki by Timo Cantell, responsible for the Urban Research Unit at City of Helsinki Urban Facts.

The concept of "soft" power has shaped a lot of international and diplomatic thinking in recent years. It has heightened interest in the principles and practices of public diplomacy and cultural diplomacy. What is cultural diplomacy? How are the wider, connective and human values of culture being used to negotiate and recalibrate international relationships in a fast-changing and sometimes dangerous world? How can culture be used to explore differences and appreciate commonalities at an international level without being turned into a tool of public diplomacy and potentially of national propaganda? Who sets the cultural diplomacy challenges and agendas and who are the players? To what extent is people-to-people communication across borders and the sharing of knowledge and information changing? Will new social networking tools and evolving social media technology present an opportunity or challenge to the future course of cultural and public diplomacy? These are some of the main questions we will debate together in Helsinki. Moreover, the seminar will be the occasion to be introduced to the curriculum of a course in Cultural exchange and Diplomacy at postgraduate level. Finally, you will also have the opportunity to listen to Jukka Hyde Hytti, Executive Producer of International Projects TINFO - Theatre Info, and thus to know more about the place of the Finnish culture in the world and the capacity of Finnish artists to efficiently promote the image of their country abroad. Marianna Kajantie, Cultural Director of the City of Helsinki, will talk to us about the Finnish identity and cultural cooperation.

## DR JENNY ELLIOTT, ARTS CARE CEO, N.I. AND PRACTICING DANCE PROFESSIONAL. UNITED KINGDOM

Jenny Elliott originally graduated through the School of Radiographers and subsequently gained her post grad teaching certificate. In her early career she lectured in Patient Care Practice Development in the School of Radiography, Altnagelvin Hospital, Derry. Jenny later trained as a Laban dance practitioner and choreographer in the late 80's. She has developed her dance artistry in Health and Education locations locally and internationally, recently undertaking a short residency in Lombardi Cancer Hospital, Georgetown University, Washington DC.

She is at present dancer-in-residence with Arts Care at, Knockbracken Healthcare Park, Belfast Health and Social Services Trust. In 2008 Jenny completed a Phd researching the impact of a Laban-based dance programme on people with an enduring brain injury and the healthcare staff who care for them. The core element of the Phd text was the use of performance and film documentary to capture the participants' experience of an arts-based activity. She is also Artistic Director of Orbit Dance and Company Maine, two integrated ability dance companies that have evolved out of her dance residency.



## TIMO CANTELL, RESPONSIBLE FOR THE URBAN RESEARCH UNIT AT CITY OF HELSINKI URBAN FACTS, FINLAND

Timo Cantell is in charge of Urban Research Unit at City of Helsinki Urban Facts. where over 20 researchers are engaged in studying various urban phenomena, including population, housing, economic issues, urban policies, cultural participation, etc. He is responsible for urban research strategy and activities within Urban Facts and develops urban research activities in liaison with universities and other research institutions located in the Helsinki metropolitan region.


#### Sanja Petricic


#### FABIEN VAN GEERT

The goal is to create an inspiring, creative community in the area whose membership neither obligates nor binds, but instead offers the opportunity of working together with others at Suvilahti.


The district will eventually house around 17 000 residents and 10 000 workplaces.

#### Niillas Holmberg & Roope Mäenpää

Niillas Holmberg & Roope Mäenpää is a fresh Sami folk-duo. They entertain with a unique style, mixing their cultural and musical back- grounds. Niillas Holmberg is from Utsjoki, or Ohcejohka in the Sami language, the second most northern village in Finland.

At 16-years old Niillas Holmberg moved to Tampere to study in Tampere's high school for arts where he met Roope Mäenpää, originally from Tampere, who had been studying cello and com-posing at the conservatory. Since then they've been making music together. You can hear many things in their music, such as Niillas's way of mixing

#### WHAT IS SAMI?

The Sámi people are the arctic indigenous people inhabiting Sápmi, which encompasses parts of far northern Sweden, Norway, Finland, the Kola Peninsula of Russia, and the border area between south and middle Sweden and Norway. The Sámi are Europe's northernmost and the Nordic countries' only officially indigenous people. Their traditional languages are the Sami languages and are classified as a branch of the Uralic language family.

They have been performing in Finland and Norway, and published their debut album "Manin guottán girjji fárus" (Why do I carry a book with me) in August 2011.

### About the social programme venues



#### Helsinki City Hall, Pohjoisesplanadi 11-13

In the heart of Helsinki's Neoclassical town centre lies the City Hall quarter, more known as the Lion Block. Most buildings here today are owned by the city. The Lion Block as it stands today dates from the early 19th century. The building was designed by the Russian Tsar Nicholas I favourite architect; C.L. Engel, and was the centre of society life in the 19th century Helsinki. 1901 the city purchased the site with the intention to build a new town hall on it. However, the plans lay dormant for many years. During the First World War Helsinki was a military hospital base for the Russian army, and the building became a Russian naval hospital. It was only in the 1920's that the building was refurbished to suit its new role as a town hall. The Helsinki City Council held its sessions at the city hall 1932-1965. Today the City Hall houses City offices and the main hall is used for receptions and official events.



#### THE CABLE FACTORY, TALLBERGINKATU 1 C

Finlands first cable business was established in 1912 as Arvid Wikström founded Suomen Kaapelitehdas Oy. For production to grow a new factory was to be built. The new Cable factory was designed by Wäinö Gustaf Palmqvist and built in three stages during the years of 1939-1954. At the time the Cable Factory with its 55 800 m2 was the biggest building in the country. As the city grew and residence buildings were planned in the neighbourhood of the Cable Factory, there was a decision to relocate the factory. As industry moved out, the space was rented out to many artists and businesses. As the factory building was handed over to the city these artists and businesses risked being thrown out as the city did not want to save the building. Pro Kaapeli was formed by the tenants to save the building, and after a lot of work and as a committee was formed by the city to work on cultural activities in Helsinki, the plan changed and the city decided to keep the factory in its original form.



#### Lasipalatsi & Bio Rex, Mannerheimintie 22-24

Lasipalatsi (Glass palace) is one of the premier functionalist style buildings in Helsinki. The building, which contains businesses, restaurants and a movie theatre, was originally planned to be a temporary structure that was supposed to be demolished in favour of a new bigger business complex. The inhabitants of the city protested against the demolition again and again, and even the The National Board of Antiquities started to favour the protection of the building. After years of not being taken care of, the building was finally protected and renovated into a cultural and media centre in 1998.

Bio Rex is the only historically restored cinema in Finland. Today it is mostly used for private events and movie festivals. When Bio Rex was built it was one of the biggest movie theatres in the city and the opening night galas for many Finnish films were held there.

## Helsinki Metropolia University of Applied Sciences, Bulevardi 31

In the heart of the Kurki neighbourhood next to Hietalahti marketsquare we find what today is the main building of Metropolia University of Applied Sciences. The building was originally built for the Polytechnic school of Helsinki in 1877. F.A. Sjöström was the architect . If you look at it today the three first floors in the middle part are from that first era of the building. In the late 1920's extensions were made to the building where decorations and roofpaintings were made in a classical style. During the war the building was bombed twice, first in 1939 and then in 1944. After the bombings it was almost completely restored, but in 1964 the polytechnical collage moved away form the buildning and it was left to deteriorate for three decades before new renova-


tions took place in 1991. Metropolia was formed in 2008 when two other schools, EVTEK University of Applied Sciences and Helsinki Polytechnic Stadia, merged. Metropolia has 15 different campuses in the Helsinki metropolitan area, and this building on Bulevardi 31is the main building of the university.

It provides through engagement with its partners in governments and cultural organisations a two-way flow of knowledge related to new learning strategies, employment competencies and attributes for future cultural policy makers and managers.
- 5. **RESEARCH:** ENCATC carries out, publishes, presents, and disseminates research in arts and cultural management and cultural policy to strengthen the understanding of cultural management and cultural policy issues in the academic, political and professional field. It promotes access to cutting—edge research and publications on cultural management and cultural policy. ENCATC also ensures that research feeds into policy making and decision makers have a better understanding of cultural policy and educational issues and ways to address them.
- 6. **COOPERATION:** ENCATC maintains close relationships with emerging countries, including Brazil, Canada, China, Hong Kong, and the USA. It also regularly nourishes its close links with partners and institutions based in Europe and beyond. Among our major partners we count the European Cultural Foundation, ESEF, EFACCA and AAAE IFACCA, Interarts, ERICarts, EUROPA NOSTRA, European Council Music, CAE, and EFA.
- 7. MOBILITY: ENCATC encourages the mobility of educators, students, artists and cultural managers actively across the sectors and among countries because this experience is invaluable for skills development and contribution to the Europe 2020 objectives for smart, sustainable and inclusive growth. Increased mobility of academic, researchers and students in cultural management and cultural policy contributes to the reform and modernisation of education and training systems by facilitating cross border dissemination of ideas and best practices.
