

### Cultural management is an enabler for environmental sustainability

Dear colleagues,

From constant news and warnings from scientists on pressing issues of global warming, pollution, and resource depletion, it can be overwhelming to think of our planet's future. We know governments are creating policies, regulations are put in place, international accords are signed, but do you ever ask yourself: What can I do right now today that will make a difference? What actions may I implement in my own organisation to contribute to a more sustainable environment? How can I teach to my students to be a responsible cultural managers?

I was inspired by the 2015 French documentary "Demain" (Tomorrow). It sets itself apart from many environmental documentaries with its **optimistic look** at making the world a more sustainable place for all of us to live. Its stories, following the actions and solutions of everyday citizens, prove the choices we make (big or small) can make a difference for a better, greener planet.

Our newest training offer "Cultural Management and Environmental Sustainability" on 14 December in Brussels will be without any doubt, an inspiration for each participant, to take action towards environmental sustainability in his or her own cultural institution. Organised in ENCATC's Breakfast format to provide an intensive learning experience, it will show how environmental sustainability is also intrinsic to the resilience of an arts organisation and makes economic as well environmental sense.

At the core of this training, Julie's Bicycle, a charity in the United Kingdom,

will testify through the voice of Catherine Bottrill, Creative Green Lead, about its established and extensive methodology for environmental change through culture. The training will also propose other models, share expertise and practical resources, and present case-studies to inspire participants to act on climate change.

To keep the focus on this important theme, this number of our monthly newsletter, includes an **interview** with our coach **Iphigenia Taxopoulou**, Associate Partner at Julie's Bicycle and General Secretary at mitos21. She speaks about the overcoming obstacles facing cultural managers to implement change, debunking myths on what and what is not achievable, and what participants can expect from the training.

To follow the successful format of the film "Demain" the ENCATC Breakfast will provide participants with success stories from different countries and organisations.

I am personally very keen to follow this training to be able to continue, and bring to the next phase, the action plan that I have designed few years ago to position ENCATC as a leading organisation in terms of green policy and social corporate responsibility. In the past 15 years, ENCATC has proved its commitment to reduce its carbon footprint by embracing the "Kilometer Zero" policy- a global concept aimed at reducing as much as possible the distance between the consumer and the supplier, as well as by giving preference to companies, entrepreneurs,

and partners who are making good choices for our planet: reducing waste, saving energy, supporting local service providers, and buying organic and locally sourced food. We have also changed how we communicate and share information. Just in 2016, through our e-publications ENCATC saved 33 trees or the equivalent of 278,169 pages\*. We encourage our staff and board members to choose public transportation, slow travel and virtual meetings when possible to reduce our carbon emissions. However, after a talk with Iphigenia, I am convinced I can do much more!

We have compiled in the full version of this issue for ENCATC members seven publications in English, French and Spanish (pages 28-29) on this specific topic. I am sure that this reading together with our intensive programme will offer a unique occasion to set new actions, policies, and training offers leading to better environmental sustainability.

### Discover the attractions of the city of Bucharest!

### 26th ENCATC Congress to take place from 26-28 September 2018

We can't wait to see you next year in Romania for the **26th ENCATC Congress on Cultural Management and Policy!** Organised in partnership with our member, The National Institute for Cultural Research and Training (NIRCT), this will be your international gathering to get the latest advancements in cultural management and cultural policy education, training, practice, and research.

Hosted in the **capital city of Bucharest**, you'll have a whole new culture to discover. Let's play a game of "Did you know?" and learn about some of the city's cultural treasures.



The **Romanian Athenaeum** gives the Royal Albert Hall a run for its money! Opened in 1888, the ornate, domed, circular building is the city's main concert hall and home of the "George Enescu" Philharmonic.



George Enescu is one of Romania's most celebrated musicians and composers. Pablo Casals described Enescu as "the greatest musical phenomenon since Mozart and "one of the greatest geniuses of modern music". Yehudi Menuhin, Enescu's most famous pupil, once said about his teacher: "He will remain for me the absoluteness through which I judge others", and "Enescu gave me the light that has guided my entire existence."



"Little Paris of the East" is the nickname given to the city in the early 20th century. It is home to impressive architecture with a prominent French influence with its Art Nouveau style and grand municipal buildings.



The **Palace of the Parliament**, is the world's second largest building (after the Pentagon in the United States) and is the world's heaviest! The gargantuan concrete building was erected in the 1980s under the Ceauşescu regime. A tour inside gives a glimpse of a small selection of its 1,000 plus rooms decorated with ornate interiors.



Carturesti Carusel may be one of the coolest bookstores in the world. In the heart of the city's buzzing Old Town (Lipscani) a huge range of books, stationary and novelty items line the walls of this gorgeous galleried space. You can also peruse a vast vinyl collection and enjoy one of Bucharest's most expensive coffees.



The **Memorial of Rebirth** on Revolution Square is an unforgettable 25 metre-high blood-soaked marble obelisk that pierces through a basket-like structure. When unveiled in 2005, it wasn't very well received by locals, but for sure it is a monument you will never forget.




The National Museum of Contemporary Art is the city's newest museum displaying works of Romania's contemporary artists as well as many international artists. It is housed in a wing of the Palace of Parliament, the space which would have served as Nicolae and Ileana Ceausescu's private apartment (where just the bathroom occupied 680 ft² or 63 m², while the adjoining boudoir was three times that size).

ENCATC is organising a new training offer! On 14 December in Brussels, the ENCATC Breakfast "Cultural Management and Environmental Sustainability" training will make the case for action on climate change and the environment by the cultural sector.

The creative community is uniquely placed to respond to one of the major challenges of our times: climate change and the environment. Arts and culture are the true barometers of the world around us; they influence our individual and collective experiences, and shape the decisions we make. Cultural institutions and arts organisations can therefore be a platform from which to engage and inspire action on climate change. Environmental sustainability is also intrinsic to the resilience of an arts organisation and makes economic as well environmental sense.

The creative climate movement is growing momentum and speed internationally, embedding sustainability as a core principle and value. The Paris Agreement on Climate Change is an opportunity for the cultural sector to assume some leadership, and to use creativity to prompt environmental change: by adapting **how cultural institutions run operations**, how cultural influencers **prepare policies**, or how **artists create their work**.

Thanks to the expertise of our two coaches, **Iphigenia Taxopoulou**, Associate Partner at Julie's Bicycle and General Secretary at mitos21, and **Catherine Bottrill**, Creative Green Lead at Julie's Bicycle, learn about the approach developed by Julie's Bicycle, a charity in the United Kingdom. For over 10 years, Julie's Bicycle has estab-

lished an extensive methodology for environmental change through culture. The organisation has had fantastic results with its Creative Industry Green Tools (IG Tools) which are a set of free online carbon calculators. The tools are currently used by more than 3,000 arts and cultural organisations worldwide from over 15 countries. In addition to learning about IG Tools, this training will also explore other interventions, share expertise and practical resources, present case-studies and success stories, and inspire participants to act on climate change.

The ENCATC Breakfast's small and intimate learning format improves the learning experience, encourages discussion with experts, and fosters exchange of knowledge, experiences, and practices. The experience has been much appreciated by previous participants. Arjen Gerretsen, UNESCO Liaison Office in Brussels, has said: "The ENCATC Breakfast I attended was time well spent. 

On 20 May 2012, the CAA was upgraded to the Ministry of Culture as part of a larger governmental reorganisation. This move served to rectify long-standing issues concerning personnel and resource allocation that had plagued the cultural sector. The Ministry of Culture oversees and cultivates Taiwan's soft power in the areas of arts and humanities, community development, crafts industry, cultural exchanges, international cultural participation, heritage, literature and publishing, living aesthetics, TV, cinema, and pop music.

### ENCATC Agenda: People, Places & Meetings

What was ENCATC up to in September and October? The ENCATC team led by the ENCATC Board and Secretary General regularly meet with policy makers, influencers, new partners, and members to foster partnerships, develop new projects, and expand the network's visibility in Europe and beyond. Here's a selection of key meetings and visits:

### 7-8 September in Brussels, Belgium:

ENCATC Secretary General, GiannaLia Cogliandro Beyens attended the joint meeting of National Coordinators and the Stakeholders' Committee for the European Year of Cultural Heritage to discuss the Commission's planned initiatives for the special year, discuss the communication strategy, how to pool resources, and foster cooperation at the national and European levels.

### 11 September in Brussels, Belgium:

ENCATC Secretary General, GiannaLia Cogliandro Beyens met with representatives from the Spanish Embassy in Brussels to present the network and discuss future possibilities to collaborate on events and cultural activities in Brussels.

### 20 September in Brussels, Belgium:

ENCATC Secretary General, GiannaLia Cogliandro Beyens, met with representatives from DIK, an ENCATC member that is a professional association and a trade union for university graduates in the fields of documentation, information and culture. She presented the work done by ENCATC as well as opportunities for students just heading into the job market.

As one of the networks supported by the Creative Europe programme of the European Union for the period 2017-2020, ENCATC was invited to the kick-off meeting of networks. ### 18 October in Brussels, Belgium:

# ENCATC's 25th Congress looks to the current and future trends of cultural management and cultural policy

The 25th ENCATC Congress "Click, Connect and Collaborate! New directions in sustaining cultural networks" took place in Brussels, Belgium from 27-30 September 2017. This major international event brought together more than 230 participants who were academics, researchers, professionals from the cultural sector, policy makers, artists, students and media from 40 countries.

For the first time in 2017, to mark the **network's 25th** anniversary and the next chapter in its evolution, the Congress encompassed a new enlarged format that included the 10th Young and Emerging Researchers' Forum, the 2nd Annual Members' Forum, the 25th Annual ENCATC Congress, 7th ENCATC Policy Debate, the 8th Annual ENCATC Research Session, and the 4th ENCATC Research Award Ceremony. This was a significant development for the network, its members and followers who increasingly represent a more international audience. The new format ensured interesting content for a diverse audience and rich exchange and cross-pollination between education, research, training, and practice.

25<sup>th</sup> ENCATC Congress kick-offed on 27 September at the Bip, house of the capital region. The morning began with the 10<sup>th</sup> Young and Emerging Researchers' Forum. The 2017 edition was designed for young and emerging cultural policy researchers to help them advance in their careers and enlarge their networks in Europe and beyond.

Participants exchanged research trends, addressed topical research issues, methodology, professional cooperation, publishing opportunities, online knowledge exchange and collaboration. In addition, this year's YERF particularly encouraged dialogue on cultural management and cultural policy/governance studies, and with a focus on Asia and Europe regions.

That same afternoon, the **2nd Annual Members' Forum** gathered ENCATC members as well as members of the networks the Association of Arts Administration Educators (AAAE) and the Taiwan Association of Cultural Policy Studies (TACPS). This plenary session started with an **exchange** on **cultural management and policy education from a global perspective** with representatives coming from across Europe, the Americas, Africa, and Asia. The Members' Forum was also the opportunity to learn about **new curricula, pedagogy, methodologies** and **policies** with presentations prepared by members for their peers.

The day concluded at BOZAR, the Centre for Fine Arts in Brussels where all Congress participants were invited to a cocktail reception followed by the 7<sup>th</sup> Annual ENCATC Policy Debate "What role for Brussels and its cultural institutions in the EU strategy for culture external relations?"

On **28 September**, the Congress opened to all delegates. After the **official welcome**, the programme began with a

plenary session panel debate on the "Evolution and impact of the cultural management and policy network on the cultural sector in terms of its professionalisation: past, present, and future". ENCATC's past and current Presidents coming from higher education institutions in Belgium, France, Germany, and Spain were joined by GiannaLia Cogliandro Beyens (current Secretary General) who shared their reflections about the impact and importance of ENCATC during the organisation's 25 years of existence.

Next, our keynote, **Milena Dragićević-Šešić**, Head of UNESCO Chair in Interculturalism, Art Management and Mediation, Belgrade University of Arts in Belgrade, Serbia was invited to take the floor. She delivered a passionate speech on "**Networking culture - The role of European cultural networks"** and shared her expertise, creative and innovative insight providing alternative and thought-provoking ways of exploring the sustainability of cultural networks.

After the day's networking lunch, the **2<sup>nd</sup> Global Conversations**, organised in partnership with AAAE and TAPCS, offered delegates a space to debate about the Brussels manifesto, a draft document that defines a common set of guiding principles and aspirations for the arts and cultural management education field. The draft document is an outgrowth of the Dialogue of Networks, a session that took place at the 2017 AAAE conference in Edinburgh, Scotland where more than 15 networks engaged in a process to identify the key ideas in the Manifesto. Now, at this year's ENCATC congress, discussions brought new perspectives and deeper reflection to refine the document even further before it is presented externally in the coming months.

Continuing in the afternoon, participants separated into four parallel discussion groups to advance the state of art and promote new ideas and proposals on the major challenges faced by cultural networks today in Europe and beyond: Governance/Leadership; Business Models; Evaluation; and the Internationalisation of Networks.

The evening programming was dedicated to the **4**<sup>th</sup> **ENCATC Research Award** where **Dr. Rebecca Amsellem** from France was announced as the 2017 winner for her PhD thesis "The international strategies of museums and their new business models" defended at University Paris 1 Panthéon Sorbonne.

The next day, the programme started with the **8<sup>th</sup> Annual ENCATC Research Sessions and Thematic Sessions**. More than 41 papers were presented by academics, researchers and practitioners from 24 countries. They shared the latest research developments and trends in the wide field of cultural management and policy covering cultural heritage,

evaluation, culture and sustainable development, cultural policy, creative industries, cultural diplomacy, performing arts, cultural leadership, just to name a few. This resulted in a published book of proceedings available for download online.

After lunch, a plenary session on "The Compendium of Cultural Policies and Trends in Europe: strategies for a new multi-stakeholder network" presented an analysis of global developments that influence cultural policies. It also explored future-proof scenarios for the Compendium research community and its database.

Next, the "Citizens' Dialogue and the European Year of Cultural Heritage" was led by representatives from the European Commission's DG for Education and Culture and DG Communication. They shared how it is possible to host one of the 2018 Citizens' Dialogues. There was a lively Q&A session on the challenges to foster dialogue between citizens and policy makers, especially the difficulties to reach marginalised populations.

To bring Congress delegates into the discussion on the 2018 European Year of Cultural Heritage (EYCH), the next plenary session focused on "EU Policy Development on Cultural Heritage". Representatives from the European Commission were joined by heritage experts and researchers to discuss the state of art of heritage policies in Europe, trends on training programmes on Intangible Heritage, collaboration and participation in cultural heritage management, and what's next to prepare for the EYCH 2018.

The day ended with a party to **celebrate ENCATC's 25<sup>th</sup> Anniversary**. Organised at BOZAR, Centre for Fine Arts, the evening was a time to share stories, look back on what has been accomplished, and how together ENCATC members and Congress delegates will be part of its future.

The last day of the Congress on **30 September** had a study visit dedicated to discovering Brussels' the European House of History. After a visit, participants met with the museum's curator to discuss practical management issues, questions of the pedagogical digital materials, and reactions to the purpose and design of the exhibition space.

In a final get-together moment, everyone was invited to enjoy traditional Belgian fries at Maison Antoine, one of the most recognised "friterie" in the city.

There is no doubt this major international gathering was a success for collecting **new ideas**, sharing knowledge and different perspectives, and delivering **recommendations**. We were witness to the many networking moments and synergies initiated by our active members and Congress delegates!

## Dr. Rebecca Amsellem is named the winner of the 2017 ENCATC Research Award on Cultural Policy and Cultural Management



On the evening of 28 September in Brussels, **Dr. Rebecca Amsellem** from France was announced as the winner of the 4th ENCATC Research Award on Cultural Policy and Cultural Management her PhD thesis, "The international strategies of museums and their new business models" defended at University Paris 1 Panthéon Sorbonne.

The Award winner was revealed at the ENCATC Research Award Ceremony held in Brussels during the 25th ENCATC Congress "Click, Connect and Collaborate! New directions in sustaining cultural networks."

Addressing an international audience of leading academics and renowned researchers, representatives from the European Commission, policy makers, cultural practitioners, and artists, and speaking on behalf of the Award's international jury, Annick Schramme, President of ENCATC said: "The variety and quality of the selected finalists were very high. One was an excellent, theoretical and original reflection about the concept of audience development in relation with cultural policy and democracy; another used an innovative and mixed qualitative and quantitative methodology to measure the high perceived success of small-sized creative organisations; finally, a well-written and elaborated empirical analysis of the international strategies of museums and their business models. The jury decided to give the Award to the latter because it met the most of the ENCATC Award's criteria. The jury strongly believes that Rebecca's sound comparative and empirical research will have high relevance for the practice in different parts of the world."

ENCATC was honoured to have Catherine Magnant, Advisor, Head of the 2018 European Year of Cultural Heritage task force at the European Commission, deliver the highly anticipated Award announcement. Speaking of the Award's role in promoting important research and stimulating new thinking, Ms. Magnant said: "I am delighted to hand out ENCATC's Research Award for the third time. It is always so moving to see bright young cultural researchers have their efforts rewarded! Both the academic

world and policy makers need fresh, rigorous and independent thinking and ENCATC's Award is promoting exactly that."

The winner, Dr. Rebecca Amsellem expressed her esteemed gratitude for this international recognition: "/ would like to thank deeply the members of the jury for this honour. I would like to thank Professor Greffe for believing in this research from the beginning and accompanying me through the whole PhD. The ENCATC organisation has been a true ally to cultural researchers throughout its existence and I am truly grateful that my research is a part of it." The winner will have her PhD thesis published in the ENCATC Book Series on Cultural Management and Cultural Policy Education by the international publishing house, PIE Peter Lang.

Launched in 2014, the ENCATC Award exists to stimulate academic research in the field of cultural policy and management, to explore contemporary issues at stake and possibly anticipate new cultural policy orientations through comparative and cross-cultural research. Moreover, it contributes to the process of creating an infrastructure, a network of researchers who are doing comparative research projects in cultural policy and management issues. "The Award ceremony this year occurs on the celebration of ENCATC's 25th anniversary. I'm very proud the Award winner's research is published in our book series. This is an important contribution to the careers of emerging researchers and to the greater research community, the cultural sector, and policy making in Europe and beyond. As we move into our next 25 years, I see us continuing to bridge innovative research with education in cultural management and cultural policy. As the only network at the crossroads of culture, education, research and training, once more ENCATC demonstrates its capacity to recognise innovative applied research that policy makers can use to design new policy scenarios," said ENCATC Secretary General, GiannaLia Cogliandro Beyens.

## Issues and trends in cultural policy at an international level



On 2 October in Antwerp, ENCATC held its 8th Policy Debate on the topic of "Issues and trends in cultural policy at an international level."

44 academics, researchers, cultural operators, policy makers, economics experts and students came to hear from experts from Australia, Belgium, South Africa and the United States share their different points of view.

After a warm welcome by ENCATC's Secretary General, GiannaLia Cogliandro Beyens and an introduction from ENCATC's President, Annick Schramme, the policy debate kicked off with a lecture by Sarah Gardner, the founding director of IFACCA, the International Federation of Arts Councils and Culture Agencies. Next, Prof. dr. Cas B. (Radboud Universiteit) moderated an Smithuijsen international panel discussion with experts: Avril Joffe (Professor, Witwatersand University Johannesburg South-Africa), Richard Maloney (Professor, New York University, USA), Luc Delrue (Secretary General, Flanders Department of Culture, Youth, Media), and Barbara Stacher from the DG EAC at the European Union.

The debate concluded with reflections from Caroline Bastiaens, Vice Mayor of Culture, Economy, Urban Maintenance and Patrimony.

ENCATC is working on a report of the policy debate and a short video will also be made available.

SHARING EXPERTISE

### **European Heritage Alliance 3.3**



Members of the European Heritage Alliance 3.3 met on 18 October in Brussels. ENCATC, an active member of the Alliance since 2011, was represented by its Secretary General, GiannaLia Cogliandro Beyens.

This was an important opportunity to get the latest updates from the European Commission. Erminia Sciacchitano, Policy Officer and Member of the EYCH team, DG EAC, at the European Commission presented an ongoing mapping of cultural heritage actions in EU policies, programmes and activities, the Horizon 2020 work programme 2018-2020 published (but not yet adopted) upcoming project calls (that would offer funding of EUR 200 million for cultural-heritage related research, and funding opportunities from Erasmus+for heritage skills related projects.

Those in attendance also learned more about the EU-China Tourism Year 2018. The European Commission is preparing the ECTY in close cooperation with CNTA (China National Tourism Administration). Its main priorities are to show what the EU has to offer to Chinese visitors by supporting various cooperative marketing campaigns, facilitate business summits, and organise Business to Business matchmaking meetings for tourism operators at the most important fairs.

Members also shared their planned activities for the European Year of Cultural Heritage 2018 and possibilities for synergies among those in the Alliance. For its part, ENCATC is currently carrying out a survey for members to better understand their activities in cultural heritage. The 26th ENCATC Congress on Cultural Management and Policy (26-28 September 2018 in Bucharest, Romania) will also focus on cultural heritage and thus to contribute to the success of the 2018 European Year of Cultural Heritage.

### **Creative Ukraine Forum**



ENCATC was invited to share its expertise at the Creative Ukraine Forum held from 19-20 October in Kiev, Urkaine. This event aimed to promote and enforce the perception of "culture" and "creativity" as drivers for growth and sustainable development. The event was also intended to contribute to the promotion of inter-ministerial and public-private cooperation on elaboration of public policies and the establishment of strategic alliances supporting and promoting CCIs development locally, nationally and internationally.

The forum attracted participants from 16 countries. They were professionals from creative and cultural sectors, representatives of business and civil society institutions and projects, researchers, academics, and policy-makers from Ukraine, Eastern Partnership (EaP) countries and EU Member States.

ENCATC President, Annick Schramme was invited to speak at a special session on mainstreaming of Ukrainian and EaP cultural actors in the EU networks which aimed to investigate internationalisation, cooperation and networking as instruments for CCIs development. The session also informed participants on opportunities for more active access to Ukrainian instruments of institutional support for CCIs and EU funding through regional and international partnership development. ENCATC's President also spoke at the session "Business consultations "Creative SMEs".

Tetiana Biletska, ENCATC member from Ukraine, and Association4U Senior Sectoral Policy Fellow, and ENCATC member Eglė Deltuvaitė from the Lithuanian Culture Institute and Head of the Creative Europe Desk in Lithuania were also speakers.

# ENCATC IN CONTACT



For this edition of ENCATC in Contact, we sat down with Iphigenia Taxopoulou, Associate Partner at Julie's Bicycle and General Secretary at mitos21. She will be our coach at the ENCATC Breakfast Training "Cultural Management and Environmental Sustainability" on 14 December in Brussels. We wanted to learn more about her background and what participants can expect from the training.

# How did you get interested in the topic of environmental sustainability?

As a cultural manager working with cultural primarily public institutions, I've always identified efficient management with "good house-keeping" and with an acute sense of social responsibility. Through my working experience (in the theatre sector mainly), I had begun to feel increasingly uncomfortable at how "carelessly" cultural institutions were run in respect of their environmental impacts: tons of paper, energy and water wasted; endless supplies to create new sets and costumes: buildings which operated environmental minefields, etc... Natural resources, materials, but also public funds, were spent as if there was no tomorrow.... I was convinced that this could be reversed if only we became aware of the environmental impact of our sector and, most importantly, if we knew how to bring about change. It was back in 2009 when I started to conduct research. I came across the work of Alison Tickell and Julie's Bicycle which had been founded the year before. This pioneering initiative provided the precise framework, the data, the arguments and the tools, which would enable the cultural sector embed principles environmental sustainability in its overall ethos and daily operations. Our paths crossed in 2013, when we, as mitos21, organised the first



international conference on "Sustainable Cultural Management" – we have been working together ever since. Currently, we are in partnership for a new educational project, the EU funded Creative Climate Leadership training course.

# What is your role in the mission of Julie's Bicycle as an Associate Partner?

As an organisation, JB is a charity based in London. You will be surprised to know how small the core-team is, in relation to their immense achievements in bridaina environmental sustainability and the creative sector, not only on a national level (in the UK, where they practically helped create a new framework for the national cultural policy), but also on an international level. Part of this international work is done through a network associate

individuals who are, so to speak, the ambassadors of JB worldwide. JB is by principle a very decentralised organisation – the idea is to reach out to as many people and institutions in the cultural sector as possible, to inspire action, provide the knowledge, the tools and the resources, so that they can then pursue this new approach independently (and, hopefully, inspire others!).

In your role as Secretary General of mitos21, what are some of the changes you have established in the network to make a positive impact on the planet? Have you been successful in getting your members to also adopt any practices?

As I mentioned before, among our other mitos21 projects, in 2013 we organised an international conference entitled "Sustainability and Culture / Sustainable Cultural Management";



and then, in 2016, together with JB, we organised the first International Intensive Summer Course Sustainable Cultural Management (SCM Course). Both initiatives came about because the members of mitos21, representing some of the most prestigious and influential theatre institutions in Europe, are fully aware of their responsibility to operate in an environmentally responsible manner. There are different degrees of integration of sustainable management in our member-theatres. Some, like the National Theatre in London are truly "examples to follow". Others are beginning to develop their "green" projects, others are half-way through. For this reason, we have set up an internal network of mitos21 "green managers", to provide mutual share knowledge support, exchange expertise. In addition to that, in June 2018, we will be organising an event on Sustainability in Cultural Policy and the Arts, at the Academy of Performina Arts in Baden-Wuerttemberg.

# What are some of the obstacles you think are impeding cultural managers from implementing policies, tools, practice for environmental sustainability?

The main problem is lack of commitment, most importantly on behalf of the higher levels of administration. Experience shows that once the top administration is committed to make the change, there will usually be a wealth of good will and enthusiasm to be found across any organisation. The narrative is in place, the methodology and the tools

are available, training and support can be provided... it's just a matter of getting started. So far, surveys prove that engaging with a project of sustainable management enriches the creative life, as well as the teammorale of organisations.

# What do you say to people who think they can't make a difference because they are "just one individual" or "only one institution"?

Well, here is the good news: we are no longer "just one individual" or "only one institution". Currently, there is a large wave of creative people worldwide who are actively engaged in doing their part against the devastating effects of climate change and environmental degradation. I do not necessarily refer to direct activism, as there are many artists working in this direction. I am talking about individuals and institutions that continue to create art and culture, only that they do so via a different mind frame.

# What about the cultural sector makes it an ideal platform from which to engage and inspire action on climate change? What advantages does it have that makes it different from other sectors?

The creative and cultural communities – more than any other sector per se – define, design, develop and affirm social values. Be it through the arts, theatre, music, film, or fashion, the cultural sector is a powerful driver of values and life styles, which has direct access to the minds and hearts of people across the globe.

# What are the top three things you hope Breakfast participants leave with after the training?

I hope they will have found replies to the "why", the "whether" and the "how". We will endeavour to show why it is important to engage; to inspire a desire for commitment; and to provide an introduction to basic knowledge and the tools that would allow our participants and their organisations to embark on their own sustainable project.

# MEMBER STORIES: FRANCE, ROMANIA, SPAIN ENCATC members come together for the 4th National Conference of Cultural Managers

This conference took place at the National Library of Romania from 28-29 October, in the presence of the Minister of Culture and National Identity, Mr. Lucian Romascanu, ENCATC's former President Lluis Bonet and current Vice-president Mrs. Manuèle Debrinay-Rizos, Nigel Bellingham – Director of British Council Romania, Secretary of State Gheorghe Popa, other state officials and over 150 managers and representatives of public cultural institutions at a national level.

During his speech, the Romanian Minister of Culture mentioned the importance of cultural management's role in public institutions and underlined the benefits of having three international guests from ENCATC sharing their experience with the Romanian cultural managers and cultural policy-makers.

Associate Professor Carmen Croitoru, PhD - General Manager of NIRCT - stated that the role of the cultural managers is fundamental in laying the cornerstone for a well -organised cultural public institution. She also underlined the importance of belonging to an international network such as the ENCATC. On this occasion, NIRCT publicly announced ENCATC's 26th Congress will take place in Bucharest in 2018, when Romania will celebrate a century since the Great Union of 1918.

For the second consecutive year, three ENCATC members were invited to share their expertise. Manuèle Debrinay-Rizos presented ENCATC and its role in connecting cultural managers worldwide and the importance of networking and the development of local cultural policies. Professor Bonet from the University of Barcelona presented on "Models of governance in public cultural management. Limits and opportunities" was a focal point of the debate, raising the interest of the participants. Professor Camille Jutant from University Lyon 2 talked about the importance of the education in training future professionals in the field and especially interdisciplinarity, transversality of skills.



The event also included the official release of the book entitled *Theatre Management*. Strategies for theatrical organisations by Professor Bonet. The book was translated, edited and published by the National Institute for Cultural Research and Training. This book aims to be useful not only to those working in theatres, but also for all museum managers and cultural managers in a broader way. Lluis Bonet thanked the Institute and to its General Manager for this effort, as the Romanian version of it appeared before the English one. This project is the materialisation of the good cooperation and fruitful cooperation under the generous umbrella of ENCATC.

### The Management of Cultural Heritage and Landscape Inner Areas. Theories and Practices Across Europe and Beyond

### Deadline for abstracts: 31 December 2017

At the beginning of 2017 the European Union designated 2018 as the first European Year of Cultural Heritage, an opportunity to reflect on the value of cultural heritage and raise awareness of its social and economic role in current society.

This initiative falls in a very particular moment for Italy, in the middle of the debate on the restoration and reconstruction of inner villages and historical buildings damaged by the series of earthquakes that struck the central part of the country between August 2016 and January 2017, and in the aftermath of the launch of the National Strategy for Inner Areas (2014-2020). Inner areas, that cover most of the European territory, have undergone a process of persistent marginalisation and depopulation since the post-war period: far from communication routes and hubs providing essential services (education, health and mobility), they are today a European emergency, because of abandonment and aging population, low levels of employment and scant industrialisation. The survival of cultural heritage in these disadvantaged areas - in many cases, mountain areas - is compromised and its sustainable management is a complex and transdisciplinary issue requiring a multi- and interdisciplinary approach and asking for the fruitful collaboration between scholars and policy makers.

Italy plays a key role in the international debate on this topic, not only for the *continuity*, the all-encompassing and pervasive distribution of cultural heritage in its territory, included in inner areas, but also for the *vulnerability* of its landscape.

Given this context, the international scientific journal "IL CAPITALE CULTURALE. Studies on the Value of Cultural Heritage" has decided to launch a call to collect and compare different perspectives, approaches and experiences on the management of cultural heritage and landscape in inner areas in and beyond Europe.

# Theatre Between Politics and Policies: New Challenges

### 23-24 March 2018 in Belgrade, Serbia



When analysing the relationships between theatre and politics in a contemporary context, we do not consider only the direct use of a political theme in theatre practice. Rather, we aim to rely on theoretical proposals that suggest the politicality of theatre is realised through the modes of representation on stage. This implies that, in order to have a political impact, it is no loner enough for theatre to point our political and social issues of the community. Instead, it needs to further its artistic strategies and models of production as elements and agents of theatre's politicality.

On the other hand, the impact of public policies, or their implementation in the field of culture, is also reflected in contemporary forms of theatre practices. Thus, modes of funding and other forms of public and cultural management largely influence potential forms of theatre's politicality. This two-way direction of a dynamic relation between theatre and politics enables scientific and theoretical thinking on contemporary theatrical expressions from difference angles and perspectives, some of these being: What political discourse se talk of in the context of theatre practice? What is the political reach of theatre in current social context and how is it realised? In which way do policies influence the impact of theatre?
