FOREWORD



Dear members,

Dear participants,

It is with great pleasure that we welcome you to Helsinki for the **2023 ENCATC Congress** on Cultural Management and Policy "**Artificial Intelligence Embraced: the future of the cultural and creative sector**".

This year has brought Artificial Intelligence to the fore of public consciousness. Across all fields, the potential applications of AI and the challenges which accompany it are pressing matters for discussion, and the topic is just as urgent in the cultural and creative sector. **AI will have a massive impact on our professional lives** and on the transformation of practices in our educational and cultural institutions.

Organised in partnership with our members **Sibelius Academy/Uniarts Helsinki, Arcada University, Humak University, Metropolia University, Cupore and Seinäjoki University**, the ENCATC Congress 2023 will offer a unique opportunity to analyse and debate the many ways in which AI may be implemented and impact our research and practice, examine ethical, social and legal implications, and imagine new possibilities for the future of the culture and creative sector.

The Congress will start on the 11th of October with a sound performance by the audiovisual artist **Jonatan Snapir**. The Congress will open with an Introduction to the concept of AI by **Leonardo Espinosa Leal**, Principal Lecturer in Technology at Arcada University, and will be followed by a talk by **Stefan Lindström**, Ambassador of Digitalization and New Technologies of Finland. Together, they will provide us with the basis to understand the different interventions of the 3-day programme. These interventions will be followed by a dedicated **panel in response** involving experts from the academic, institutional and practitioners' fields, to further assess the impact of the AI in management, research, education and artistic practice.

In the afternoon, participants will be invited to visit one of the **five cultural institutions** who have partnered with us: the **Museum of Contemporary Art, Kiasma, Helsinki Central Library Oodi**, the complex of the **National Museum of Finland**, the **Amos Rex** museum and the **National Opera**.

Finally, to close the first day, participants will come together for an exclusive **reception at the Helsinki City Hall**. There, we will be welcoming talks from the city officials and a musical performance by the **Duo Emilia Lajunen & Suvi Oskala**, a five-string fiddle duo promising to enchant us with traditional Finnish tunes blended with new compositions.

On the 12th of October, the day will start with a **Keynote speech** by **Oonagh Murphy**, Senior Lecturer in Digital Culture and Society at the Institute for Creative and Cultural Entrepreneurship of Goldsmiths, University of London. Professor Murphy will enlighten us on the key **ethical questions** of the use of technology in the cultural field. In response to her vision, a **high level panel**, composed by experts from different regions and horizons, will follow.

The second day will also celebrate **young, emerging and confirmed researchers** coming from all the World regions, through a number of consolidated ENCATC initiatives: the **Education and Research Session**, the **Young and Emerging Researchers Forum**, the **ENCATC Award Ceremony** and the Ceremony for the **Best research paper**.

The programme of the 12th of October, also includes both the annual **ENCATC Policy Debate** initiative, this year focusing on "**Global perspectives in current and future trends on cultural policy**", and six **Members Talks**. Designed to contribute to the **2023 European Year of Skills**, they address a variety of topics, from the use of AI in cultural marketing to emerging profiles and curricula in the cultural and creative sector, to skills for the green transition in the CCIs. The second day will end with a **networking dinner** including a special performance by the ENCATC member and recognized Finnish pianist **Osmo Palonen**.

On the 13th of October, the day will begin with a captivating morning concert by **Pajuh's Electro-Acoustic Trio**, an experimental electro-acoustic project combining multiple genres and rhythms. After this morning Concert, all the attention will be devoted to **Prof. Lluís Bonet**, Professor of Applied economy and Director of the Cultural Management Programme at the University of Barcelona, our **2023 Laureate of the ENCATC Award for Outstanding Contribution** to cultural management, education, research, and policy.



The ceremony in his honour will include speeches both from the laureate and ENCATC Board members. In the afternoon the 2023 edition of the **Global Conversation** will focus on how AI is redefining the boundaries of **film and music industries**, involving expert speakers from all corners of the world in a stimulating exchange. Finally, the Congress will conclude with a performance by the **quartet Wanne**, bringing together percussions, flute, double bass and marimba with vocals.

This year's Congress is once again an opportunity for ENCATC to demonstrate its closeness to the **key challenges affecting the cultural management and policy community** and its strong commitment to continue leading the debate on the solutions to overcome them.

Guided by our **environmental sustainability policy**, we continue with our practice to reduce our impact as much as possible - through the promotion of sustainable travel conditions, the pursuit of awareness raising also among our partners, the attention to waste management - with a preference for reusable, recyclable or compostable items - and the commitment to purchase local products.

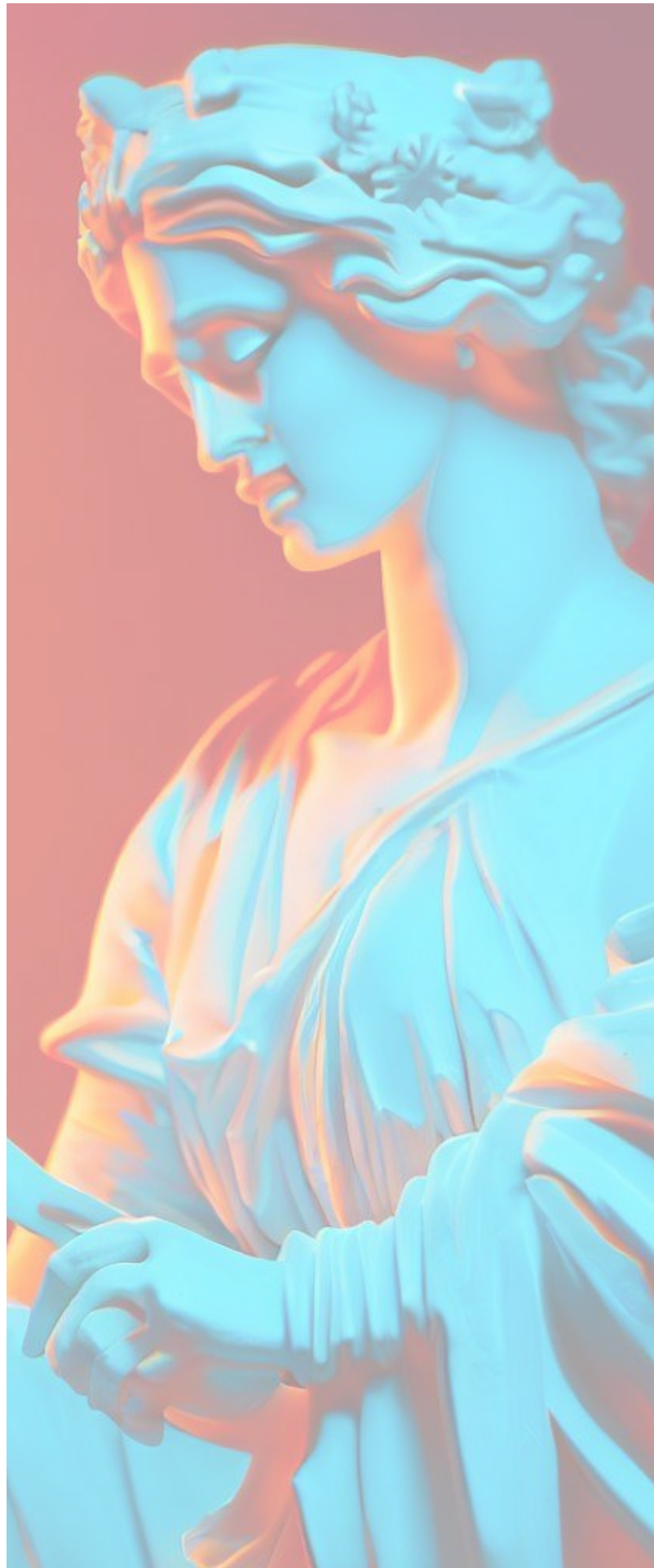
Our profound hope for this new edition of our annual Congress is that the programme will help each participant gain new policy and research approaches and practices in cultural management education and policy.

2023 CONCEPT NOTE

Artificial Intelligence: impact on cultural policy, management, education and research

According to the European Commission's Communication on "Artificial Intelligence for Europe", published in 2018: "Artificial intelligence (AI) refers to systems that display intelligent behaviour by analysing their environment and taking actions – with some degree of autonomy – to achieve specific goals". AI is strongly present across society and life areas, and culture is no exception. The Congress on "**Artificial Intelligence Embraced: the future of cultural and creative sector**" aims to explore the impact of Artificial Intelligence (AI) on the cultural field with a focus on the opportunities and challenges.

AI is **influencing cultural policy** in various ways. For instance, AI-powered tools can provide policy makers with insights into the cultural and creative sector's economic impact, helping them make informed decisions about funding and support. Additionally, AI can assist policy makers in identifying and addressing issues related to diversity, equity, and inclusion in the cultural sector. Parallel to that, it is also under policymakers' remit to respond to the increasing demand of higher transparency, intelligibility and accountability for the AI (Merzagora, Ghilbert & Meunier, 2022). In this sense, as pointed out by Octavio Koulesz, "It will be essential to develop strategies that go beyond a merely abstract code of ethics and design public policies to ensure that AI systems – and the actors that exploit them – are auditable and accountable" (2018, p. 2).

AI is also transforming the management of the cultural and creative sectors. The use of AI and digital technologies has indeed revolutionized the cultural and creative industries (CCI) (Caramiaux, 2020; Murphy, 2019; Pisoni et al., 2021) and their link with other sectors and fields. It has disrupted their value chains (Fuglsang, 2023), triggering new cultural policy and management reflections (Robinson, 2020; Townse, 2020), and offering new educational opportunities and threats that need to be further explored in terms of their ethical and educational approaches (Malik, Tayal & Vij, 2019). AI-powered tools can analyze data on consumer preferences and market trends, helping cultural organizations make informed decisions about programming, marketing, and audience development.

Moreover, AI can automate administrative tasks, freeing up time for creative professionals to focus on their craft. The whole cultural and creative sectors are therefore experiencing an unprecedented opportunity for innovation but also on reflection on the potentialities and threats of these technologies.

AI is changing the way we learn about and engage with culture. For instance, AI-powered tools can enhance the learning experience by providing personalized recommendations, feedback, and assessment. Additionally, AI can help educators in the field of cultural management and policy design and deliver more effective and engaging educational programs. However, in its automatising nature, "there is [also] a risk that AI might be used to scale up bad pedagogical practices" (Tuomi, 2018, p. 4). Furthermore, a deeper reflection on how AI itself is taught and learned needs to take place; beyond basic knowledge about its functioning, education and training there exists an increasingly need to focus on "how AI is made visible and recognisable and how it is represented (...) essential aspects if we want to preserve a capacity to operate informed choices about AI" (Merzagora, Ghilbert & Meunier, 2022, p. 131).

Finally, AI is revolutionizing research in the field of cultural management and policy. AI-powered tools can analyze large data sets, identify patterns and trends, and generate insights that can inform research and scholarship. Moreover, AI can enable new forms of interdisciplinary research by facilitating collaboration between cultural researchers and experts in fields such as computer science, engineering, and data analytics.

In conclusion, AI is having a profound impact on cultural policy, management, education, and research. As AI continues to evolve, it will undoubtedly play an increasingly critical role in shaping the future of culture and creativity.

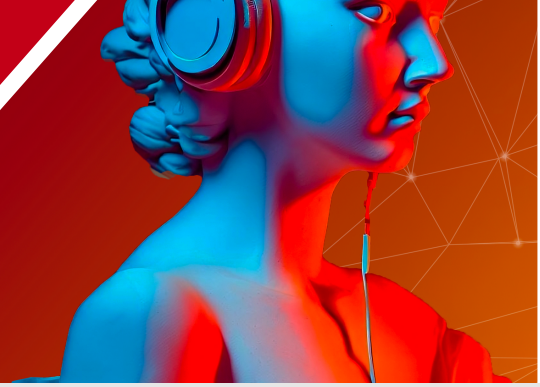

The Museum of Contemporary Art Kiasma is part of the Finnish National Gallery, along with the Ateneum Art Museum and the Sinebrychoff Art Museum. The Finnish National Gallery is Finland's largest art museum organisation.

Kiasma organises exhibitions, performances and events. Public programming in Kiasma makes contemporary art accessible to everyone. Its services range from colour play for toddlers to art workshops for grownups to guided tours and events. Kiasma's extensive educational programming integrates contemporary art into schoolwork.

The museum also houses the Kiasma Library, which specialises in contemporary art, and the Kiasma Theatre, a stage for contemporary live art.

Kiasma not only presents contemporary art but also collects and preserves it. Its art collections are part of the collections of the Finnish National Gallery and as such it is a significant element of Finland's cultural heritage. Currently, Kiasma has over 8,500 contemporary artworks in its collections.

Amos Rex is an art museum where the past, present and future meet. Located within the functionalist landmark of Lasipalatsi, the newly built domed exhibition spaces lie under the distinctively undulating Lasipalatsi square. Amos Rex presents site-sensitive, experiential, and often technologically experimental exhibitions by contemporary artists and their Modernist predecessors. Amos Rex is owned by Föreningen Konstsamfundet, whose collection is one of the largest private art collections in Finland, covering 7,000 artworks, mostly paintings, sculptures, drawings, graphics and photographs.

NATIONAL MUSEUM OF FINLAND



The National Museum of Finland is a national cultural history museum. They engage in multidisciplinary, national and international cooperation with several partners and authorities to ensure that cultural heritage is preserved and its significance is communicated and strengthened. Their task of supporting cultural change has become increasingly important. Cultural change enables them to build an ecological and social future society with cultural well-being.

The National Museum of Finland contains the oldest and most comprehensive cultural history collections in Finland with approximately half a million objects.

The artefacts illustrate Finnish history, folk culture and the culture of Finno-Ugric peoples as well as world cultures from various parts of the world. The National Museum of Finland also documents contemporary culture in Finland. The collections are mainly accumulated through donations.

The National Museum of Finland was born when several collections were combined to form the State Historical Museum in 1893. As Finland became independent, the name of the museum, National Museum of Finland, was established. The building of the National Museum of Finland was completed in Helsinki in 1910 and opened to the public in 1916. At that time, the museum already included the Seurasaari Open-Air Museum, which was opened in 1909. Currently, the National Museum of Finland operates in a total of ten locations, and the museum collections are exhibited in other museums throughout Finland from the south all the way to Lapland.

Their programme consists of temporary exhibitions, short-term pop-up exhibitions and events as well as themed tours and workshops. Many of the events are implemented in cooperation with partners and the public. Their goal is to introduce versatile audiences to topical, interesting viewpoints to culture and history in a comprehensive fashion. www.kansallismuseo.fi

FINNISH NATIONAL OPERA AND BALLET



The Finnish National Opera and Ballet is the only professional opera house in Finland. It traces its history back to 1911 and the Ballet was founded in 1922. Performances took place in the compact Alexander Theatre for a long time, until the current Opera House provided an up to date venue in 1993.

There are generally four new opera productions and three new ballet productions staged each year. Added to these are revivals of old productions. The Finnish National Opera and Ballet performs both established classics and contemporary opera and dance works, especially new Finnish works.

In terms of personnel, Finnish National Opera and Ballet is a mid-sized opera and ballet company, with approximately 550 people on the monthly payroll from 32 countries. This includes 53 opera singers in soloist and choral roles, 74 dancers (additional 14 dancers in the Youth Company), and 111 orchestra musicians. www.oopperabaletti.fi

Navigating ethical issues in the intersection of creativity and technology

One of the key topics that the Congress will address is the **ethical considerations surrounding the development of AI** within the cultural sphere, particularly its applications in education and research. This is the most crucial aspect to analyze when dealing with the development of new technologies. While AI can bring major benefits in many areas, without an ethical compass it risks **reproducing real world biases and discriminations**, fueling divisions and threatening fundamental human rights and freedoms.

The field of culture is no exception to these mechanisms. Rather, it is **key to understanding these changes** and governing them. Stakeholders are guided by **UNESCO's Recommendation on the Ethics of Artificial Intelligence**, a framework containing actionable steps and a procedural framework for the ethical design of AI systems. The Recommendation is grounded in the adoption of ten core principles laying out a **human-rights centred approach** to the Ethics of AI, including considerations on proportionality and do no harm to right to privacy and data protection, responsibility and accountability, awareness and literacy, and human oversight and determination.

These constitute a solid basis to make strides toward responsible developments in AI, but there is still much work to be done to **provide stakeholders with actionable resources** that can ensure the effective implementation of the Recommendation. It is imperative to improve the transparency and understandability of the workings of **algorithms behind AI systems** and their potential impact on human dignity, human rights and all other spheres of social life. There is a need to understand the ways in which **AI technologies can deepen existing divides and inequalities** in the world, and how to ensure that no one is left behind in having fair access to AI technologies and being protected against their negative implications. It is also important to ensure that the increasing use of AI technology is backed up by **increased media and information literacy**, and to recognize that addressing ethical concerns should not hamper innovation, but rather **stimulate ethically-conducted research**, capable of anchoring AI technologies in human rights and fundamental freedoms.

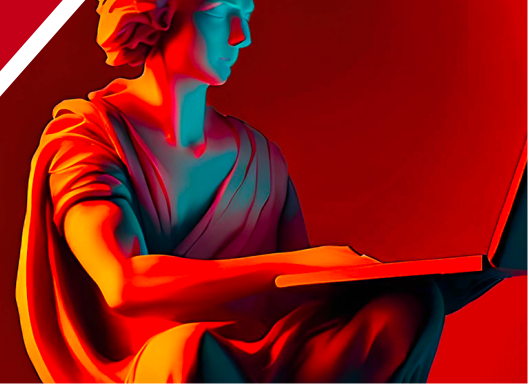

The Award consists of the publication of the winner's doctoral thesis in the **ENCATC Advances in Cultural Management and Policy Book Series**. It is co-organised by the Working Group on Skills for the Green Transformation, established in the context of the EU Large-Skills Partnership for the Cultural and Creative Industries ecosystem (CCI LSP), which over the last year has mapped initiatives in this field and identified gaps. How AI is redefining the boundaries of film and music industries?

Today, the creation, composition, and consumption of creative products from the music and film industries are being transformed. Although earlier iterations of AI technology have been in use for years, it is developing at an alarming pace without the same attention to its consequences.

Alongside this transformation, there are pressing moral and ethical considerations to address. For example, this past summer a music producer used generative AI to craft a fictitious song of Canadian artists Drake and The Weeknd, amassing millions of downloads. As one music executive stated, "you must choose between advocating for artists, fans, and human creativity or risking the proliferation of deep fakes, fraud, and the denial of artists their rightful compensation."

In the context of the ENCATC Congress, this Global Conversation will bring together the different perspectives from different world regions, providing a platform to discuss different viewpoints over some of AI's most crucial questions at the same table. The session will be chaired by Alan Salzenstein of DePaul University.

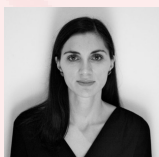

Meet the criteria

Businesses that are included in Think Sustainably get a green tab if they meet the criteria. These fit all kinds of businesses, from small cafés to big hotels, and are separated into categories like attractions, or restaurants, cafés and bars. The events category, for instance, has 23 criteria focused on areas including recycling, energy saving and vegetarian food, plus other ways of reducing the carbon footprint of events.

Another aspect to highlight is the service review system, which is based on trust and transparency. There is no auditing process for the criteria as their fulfilment is left on a trust-based agreement with the service providers. Additionally, the myhelsinki.fi website offers an easy way for users of the service to leave feedback on the brands involved. "We believe that businesses that choose to take part in this service are already motivated to change and work towards sustainability," explains Liukkonen.

Helsinki, today and beyond

Helsinki is a compact and walkable city. This, together with its popular city bike system and functional local transportation (such as rail traffic run on sustainably produced electricity), makes it easy for visitors to move about in a green way.

An impressive 40 per cent of Helsinki consists of green areas, and the city is also one of few capitals with real nature so close by. There are over 60 nature reserves in the city area and 130km of seashore open to everyone. All in all, this forms a unique experience for visitors and is a place of pure goodness – quite literally.

Thanks to its neat size, Helsinki can play around with different sustainable solutions and is a perfect example of what change on a city level can look like, done well. One can only hope that other cities will follow suit, and that the title match for the world's most sustainable destination becomes one that everyone can (and wants to) fight.

As part of the residency, a workshop with **ArtsEquator** will be organised to expose participants to different writing modalities. Participants will also put to practice skills and knowledge gained from the residency, to cover an on-site event **ASEF LinkUp | Asia-Europe Cultural Diplomacy Lab**, taking place from 24 to 27 October 2023 in Singapore, as a journalist.

Through the Fellowship, ASEF and ENCATC aim to address the **shrinking of arts coverage** and arts criticism as well as the **lack of opportunities** for young arts professionals interested in specialising in this area.



A legacy to the city of Helsinki: 2023 International Book Exchange

In case of flying, we encourage opting for a direct connection (if available), which has a lower carbon emission than a flight with a change-over. Helsinki has a very efficient public transport system and all Congress locations are convenient to reach in this way.

In the process of organising its events, ENCATC is committed to work with venues/partners who hold satisfactory environmental policies. In our contracts we include a clause to inform these actors about our Environmental Sustainability Policy and about what measures are taken to reduce the environmental impact of the Congress. 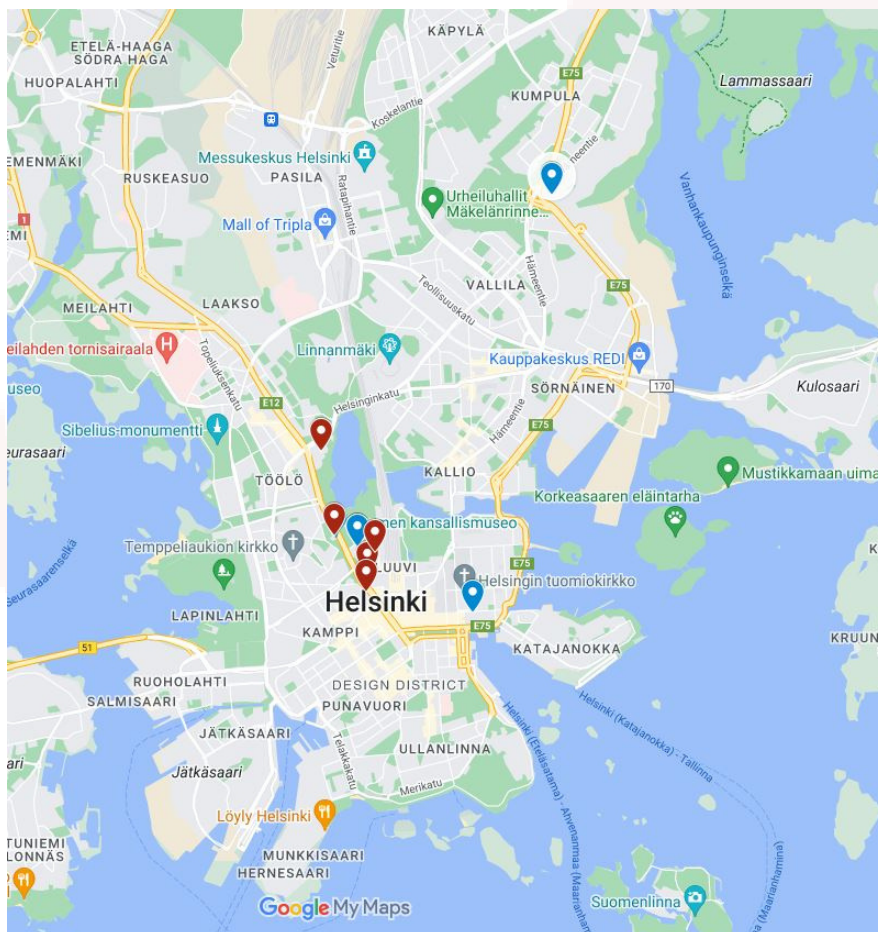
